## Ongoing charges payable to MHA

**Rent** 1-bed single occupancy: **£84.47** per week (per property)  
1-bed double occupancy: **£92.07** per week (per property)  
2-bed house: **£99.98** per week (per property)

This is payable in advance for the month ahead.

**Service charge** **£85.61** per week (per apartment)

This is payable in advance for the month ahead.

This covers communal cleaning and maintenance, external window cleaning, water and sewerage, heating and lighting for the communal areas, buildings insurance and estate management. MHA does not receive any incentives from suppliers for services paid for through the service charge.

**Utilities** Tenants pay for their own heating, hot water and water.

Heating and hot water – 1-bed apartment: **£12.40** per week (per apartment)

Heating and hot water – 2-bed house : **£13.33** per week (per apartment)

Water – 1-bed: **£3.96** per week (per apartment)

Water – 2-bed: **£4.26** per week (per apartment)

## Care charges

**Personal care** MHA does not provide personal care at Tranquility Court

## Ongoing charges payable to third parties

**Utilities** Tenants are responsible for arranging contracts with an electricity supplier.

---

**Council tax** Tenants are responsible for paying Council Tax. Band A is the band for the properties. Details are available from Leeds City Council.

---

**TV licence** Aged 74 and under is £7.50 per year. Aged 75 and over is free, courtesy of the ARC licence.

---

**Telephone** Tenants are responsible for arranging their own telephone lines.

---

**Internet** Free Wi-Fi is provided in communal areas only. Tenants are responsible for arranging their own broadband supplier.

---

**Digital TV** Tenants are responsible for arranging contracts with external providers.

## Charges when leaving

**Ongoing charges** Liability for the rent and service charge remains with the tenant or the Estate until the 4-week notice period has ended.

---

**Redecoration costs** Tenants may be charged for any repairs and redecoration that MHA deems necessary to put the property in good order for re-letting.

## Insurance

<b>Arranged by MHA</b>	Buildings, Public Liability and Employers' Liability are all included in the service charge.
<b>Arranged by Tenants</b>	Home contents insurance is strongly recommended. Tenants are responsible for selecting their own provider.

## Funding of major repairs

Tenants contribute to capital expenditure (to cover major repairs) through the rent. No additional liabilities will fall on tenants.

Within the service charge there is also an item called "amount set aside for replacements", this is a charge which goes towards the future replacement of items like: lifts, emergency call systems, door entry systems, fire alarms, communal carpets and furniture.

## Constraints on letting

Tenants must satisfy the scheme's criteria (including age and support needs). The Staff will assess this prior to letting the property.

## Access responsibilities

<b>Access for inspections and maintenance</b>	You will be required to allow MHA reasonable access to carry out any emergency repairs, to service the boiler and to carry out 6 monthly property inspections.

MHA will make every effort to agree a convenient time with you for any work carried out.

<b>Access for repairs</b>	MHA retain the right to carry out planned maintenance to your property if required. For example, replacing kitchens or bathrooms on a scheme.

You do not have the right to refuse such work, but the Estates team will give you notice of such work and the scheme Staff will make arrangements for you to use communal kitchens and bathrooms during work periods.
